

Meeting called to order at 1:00 pm by Bev Elliott, Chair pro tem as per Directors' meeting

Spring 2018 Minutes read by Carrilee Eddy Motion made to accept as read made by Nicole, seconded by Lucy. Carried

Reports:

Chair - no report offered

Vice Chair offered by Nicole - Acted as Chair after our Chair resigned. Membership, see attached. Betty asks what is put in New Member Kits. Nicole advises ACTRA Welcome Letter, pocket rule book, membership card.

Secretary report offered by Carrilee Eddy - see attached

Treasurer report offered by April Haliburton - see attached

Rules report offered by Pat Rideout - With the kind and able assistance of Carrilee Eddy, ACTRA Secretary, the rules are current and on the website. New rules that have been voted on since the little blue rule book was printed can be found on the website in the newsletter/minutes heading and titled pocket rule book insert as of March 2019.

We are nearly out of the little blue rule books and need to discuss this issue in new business.

Newsletter offered by Bev Elliott - Sent Fall newsletter, a couple of e-bulletins and emails to keep membership engaged, up-to-date with Board activity and notifications of events.

Sanctions offered by Donna Munn - see attached

Publicity offered by Russlyn Dyke - see attached

Statistician offered by Sylvia Gillies - see attached

Secretary asks for reports to be emailed to Secretary before meeting or given during meeting to help ensure accuracy of reporting to membership.

All reports were accepted as presented - moved by Sylvia seconded by Donna.

Old Business:

- a. Endurance Clinic addressed in PR report. Limited entries available.
- b. Intro Ride Betty Dwyer After discussion, edits were made to Intro Endurance ride and will trial for 2019 ride season. Report with edits attached. Original report submitted by Betty 2018 AGM. Betty moves ACTRA allow this ride type as a trial for the 2019 ride season and agrees to report on results at AGM. Dianne seconds. Carried. Lucy moves that rewrite Rule 1.9.4. to exclude Intro Distance Rides. Christie seconds. Carried. Note: Trial ride, no rule change yet.
- c. Breed Awards -Sylvia moves to include Trail Horse points in eligibility for all awards. Pearl seconds, carried.
- d. Ride Results form Sylvia asks this form be used, it will be included in Ride Kits
- e. Membership forms addressed in Membership Report
- f. Eric and Blake will look at fundraising. Absent
- g. January Thaw Nicole thanks Barb Swazey for setting up booth and helping.
- h. Judged Pleasure Sheet Bev presented edited JP sheet to use for trial, accepted.
- i. Board Governance Although Chester's motion for Chair to provide a copy of Robert's Rules of Order didn't happen, the reminder that ACTRA follows RRoO was helpful. We will continue to refer to them, thank you.
- j. AERC LD 30 minute rule change April moves to edit our rules to reflect the AERC change. Lucy seconds. Motion carried as follows:
 - 1. 6L3.2 Course completion time, which is the maximum time competitors are allowed to complete the specified course from start to finish, will be according to the Limited Distance Chart in Appendix A.
 - 2. 6.L3.4 At then finish, ride time of the competitor continues until a pre-set judging criteria of 60 heartbeats per minute or less is met. (Finishing time is recorded as the time at which the rider asks for and subsequently meets this criteria.)
 - 3. ****note. in 6L3.4 The sentence beginning with "There is no marked finish line...." is stricken from the rule because now there IS A MARKED FINISH LINE.***
 - 4. 6l4.1 All equines must stand a mandatory post-ride evaluation within one hour of crossing the marked finish line. Riders may present their equines for the final examination at a time of their choosing during the one hour period. An equine that does not meet the established criteria within one hour of arrival time shall be disqualified. Once a completed equine has passed the post-ride examination, it may not be removed from completion for veterinary reasons.
- k. Constitution posted on website
- I. ACTRA promo video Christie Cox reports that video was played at Garnet's recent Reunion
- m. Website Carrilee reports that Gallery is now working for members to post pictures in the Gallery. Sylvia expressed concern about control and at least one other member agreed.

- n. Pat moves to have New Ride Surveys created to be sent to the riders. Sylvia seconds. Carried Process to be determined by Pat, Bev, RMs. Bev agrees to work with Pat to create survey.
- o) Garnet moves to add "Recommend" to the beginning of Rule 1.3.4 and asks that concerned riders feel confident asking a judge/vet to wash/disinfect/glove their hands before touching their horse. Nicole seconds. Carried

New Business:

- a) Pat discusses the Pocket Rule books: cost of reprinting, how many to print after updating, when to reprint. Consensus is it was a great idea but not feasible to continue at this time.
- b) Christie Cox reports she has found through research that PEI will allow certain fundraising endeavours without a lottery licence. She is willing to coordinate with PEI members and help anyone interested. Much excited discussion and interest.
- c) Sylvia reminds members that the Vet Incentive for rides may is a cost that may not be a good idea as funds decrease each year. Asks members to consider whether to continue or not, reduce the amount of \$200 per day, to how much? Carrilee suggested Sylvia with Treasurer could put together a write up for the Newsletter to engage members and Ride Managers and revisit. Also discusses viewing and sending Master score sheets. Discussion, no motion.
- d) Ride Placings for Juniors Sylvia moves for a 2019 ride season trial Juniors be placed for points among Seniors with Year End awards. Lucy seconds. Motion Carried.
- e) Jean and Elliott Bridges Sportsmanship Award. Pearl Skjonsberg talks of this most prestigious award for members who exemplify sportsmanship. Lucy Rudge being the first recipient presented at PEI Autumn Ride 2016 by Ride Management. Jennifer McDonald is the second, 2018. Pearl asks if ACTRA members would like this to continue with ACTRA support or willing to cost share with Pearl & nominator/s, Committee formed? Could it be every 5 years? Interested members can email Secretary who will share with Pearl. Anyone willing to join the committee, please email Secretary or Pearl.
- f) Donna Lee asks if there is a place for Ride and Drives in our Rules since we removed Special Events. Discussion.
- g) Donna Lee asks if ACTRA/members want to plant a tree in the late David Dyke's name. This has been discussed over the years to honour much-loved members. Discussion, no motion.
- h) Donna Lee asks if Ride Kits from Sanctioning will be available on our website for those members who wish to access the kit in that way. Discussion. Bev will work with Donna Munn on that.

Reminder of Elections to be held at AGM. Three members will be at the end of their terms and we are short one Board Member. Any member is entitled to stand for nominations. If you're interested please email the Chair, Bev Elliott or any Director.

Statistician and Awards Report Spring meeting, April 28th, 2019

- The 2018 awards went well....I think. I received correspondence from only one member asking for an award clarification. There were no reports of any mileage errors or point miscalculations (yay!). It was a bit frustrating however, to plan the meal. Perhaps the traditional meeting/banquet/awards is dwindling in popularity and other options be considered (to the next person who volunteers to plan that day....good luck with that).
- I still have some certificates and plaques from the 2018 awards ceremony that need to get
 to their new temporary homes so they can be proudly displayed. Hopefully some will move
 on today. Due to the rotating postal strikes last fall I chose not to mail the plaques for fear
 they would get caught up in the conflict. I will however, mail anything that is left over after
 this meeting.
- There were two new Plaques purchased this Year for Limited Distance rides. Thank you to
 Russlyn and Dave Dyke for looking after that for me this winter. While I don't see a need for
 any immediate purchases at this time, I would like to see our standing trophies eventually be
 replaced with flat plaques as these tend to store easier and travel well.
- I like the stall plaques that were purchased for the keeper awards. They were reasonably priced, allowed for lots of flexibility in design, and they were sized and shaped to give the recipient a variety of options for storing or displaying them. I am aware however, that 2018 was the second year for these. Therefore, in the interest of keeping things "fresh", if any members have other suggestions/ideas for this award please feel free to bring them forward for discussion.
- The Board of Directors has been diligently working on updates and improvements to many of our documents. One of these amended was the Master Scoresheet for CTR/IDR. While the modifications made were minor, they were necessary to reflect rule changes and clarify reporting procedures. To that end I would ask that ride managers who are hosting CTR's or IDR's use only the Masters that are included in your kit or on the website and destroy any older copies you may have on hand from previous years.
- I believe this has been a productive winter/spring session for all of us on the ACTRA Board
 of Directors and I am sure the dialogue and the progress will not end there. As we all look
 forward to a successful competitive distance riding season I can assure you that as
 Statistician, and a member of the board and this club, I will continue to bring forth and
 discuss issues and ideas that will move this association forward in a positive and prosperous
 way.

INTRO ENDURANCE RIDE - Trial for 2019 Ride Season SUBMITTED BY BETTY DWYER

ACTRA Ride Managers may elect to host rides which are sanctioned for less than 22.5 miles. These rides are designated "Intro/Fun Rides". Intro Endurance Rides must be included on the sanctioning form and held in conjunction with an ACTRA Limited Distance or Endurance ride or an ACTRA Endurance Clinic.

- 1. Ride Managers have flexibility with Intro Endurance rides to make them a better tool for education (examples are: riding with mentors and longer time limits).
- 2. No placing or best condition will be awarded.
- 3. At least one control check point of some kind is required during Intro Endurance Rides sanctioned for 10 miles or more. (for example: pulse and go) This does not preclude the pre-ride or post-ride exam.
- 4. All Intro Endurance rides must have a pre-ride and post-ride exam completed by a control judge. These exams are to have the same requirements as any other ACTRA-sanctioned distance ride.
- 5. Riders may not elevate from an Intro Endurance Ride.
- 6. No points are awarded for the equine or owner.
- 7. Miles are awarded for the equine and rider upon completion requirements. Ride results for these distances (other than mileage) will not be reported to ACTRA and will not be published.

Addendum to 2019 Spring Meeting Minutes

As per April Haliburton's motion to reflect AERC's 30 minute rule change Submitted by April on April 30th and agreed upon by Rules Director, Pat Rideout

- 6L3.1 There may be no minimum time for completion.
- 6L3.2 Course completion time, which is the maximum time competitors are allowed to complete the specified course from start to finish, will be according to the Limited distance chart in Appendix A.
- 6L3.3 Riding time is the time used by competitors to complete the course and reach criteria, excluding all hold times. This is the time used for ACTRA ride results.
- 6L3.4 At the finish, ride time of the competitor continues until a pre-set judging criteria of 60 heartbeats per minute or less is met. (Finishing time is recorded as the time at which the rider asks for and subsequently meets this pre-set criteria.)
- 6L4 Completion requires meeting all of the criteria used for endurance rides with the exception of maximum pulse criteria upon completion of the course.
- 6L4.1 All equines must stand a mandatory post-ride evaluation within one hour of crossing the marked finish line. Riders may present their equines for the final examination at a time of their choosing during the one hour period. An equine that does not meet the established criteria within one hour of arrival time shall be disqualified. Once a completed equine has passed the post-ride examination, it may not be removed from completion for veterinary reasons.
- 6L4.2 The equine must meet a reasonable pulse recovery based on ambient conditions within 30 minutes of arrival at all control points. Maximum pulse criteria upon completion of the course is 60 beats per minute, and must be met within 30 minutes arrival at the finish line. Respiration should be evaluated on it's own merit. Ambient temperature and humidity effects need to be recognized and their effects considered.

The limited distance time chart Heading is changed as follows:

(time rider must be off the marked course,
including all holds and checks)

Pocket Rule book Edits/Additions as at March 2019

- 1.1.1 All competitors in ACTRA sanctioned rides must have proof of membership in their provincial equestrian association
- 1.1.6 Rides must be sanctioned and posted on the website a minimum of 30 days prior to the date of the ride. (Nov 2017)
- 1.1.7 Ride management should receive their sanction kits no later than two weeks before the ride date. Verbal communication requesting a ride date must be confirmed with a written request within a week to the sanctioning person in order for that ride to be approved.
- 1.1.8 Results and sanction fees are to be forwarded to the statistician and treasurer respectively within 2 weeks of the ride. The statistician will forward the ride results to the newsletter editor to be published in the ACTRA newsletter.
- 1.1.9 Annual budget of up to \$200.00 provided for sanctioning director.
- 1.11.9 ACTRA will subsidize veterinary costs for ACTRA sanctioned rides of CTR/IDR or ER/LD at the cost of \$200.00/day if the combo is held on the same day. All paperwork and sanctioning fees must be submitted within two weeks before ride is eligible for reimbursement.
- 1.11.10 When a tie is awarded the next placing is skipped. For example: if there is a tie for first place of two riders, the next placing is third.
- 1.12.1 Time allowed for reviewing score sheets/seeking correction of any mechanical error changed to 48 hours (Nov 2017)
- 1.14.3 A 5 point deduction per leg will be applied to horses wearing leg protection during a CTR/IDR.
- 2.10.4 A separate crew should be available to do all the final calculations and deduct time penalties from the sheets. After placings and awards are determined, judge should sign the score sheets. The master score sheet must be completed before judging sheets are given out to competitors.
- 2.10.5 Riders should check their sheets for calculation errors and notify management if any are found. Time allowed for reviewing score sheets/seeking correction of any mechanical errors is 48 hours for statistical purposes (Nov 2017)
- 3.2.3 IDR speed is either 4 or 5 miles/hour to be decided by ride management and announced at the time of sanctioning. (Nov 2017)
- 3.3.1 Management hosting an IDR can have a maximum distance of 20 miles and a minimum of 12 miles.
- 3.10.4 Riders should check their score sheets for calculation errors and notify management if any are found. Time allotted for reviewing score sheet/ seeking correction of ant mechanical errors is 48 hours for statistical purposes. (Nov 2017)
- 5.7.2 Scoring points for Endurance will be allotted as 11, 10, 9, 8, 7, etc. Completion placings after 10th place will get one point.
- 5.7.3 Riders should check their sheets for calculation errors and notify management if any are found. Time allowed for reviewing score sheet/seek correction of any mechanical errors changed to 48 hours for statistical purposes. (Nov 2017)

What a successful event if you were hoping to hear stories, see interesting memorabilia and feel a great sense of community spirit with fellow riders, horse lovers and enablers!

How inspiring it was to listen to Garnet, who realized simply through a willingness to say "why not? I'll try!" that he could connect with international riders and end up riding in the most exciting places, meeting all kinds of fellow riders also addicted to Distance Riding! The Annapolis Valley Challenge

Everyone loves a challenge right? Who would like to tackle back to back 25 mile Competitive Trail Rides? Or 15-18 mile IDR/JP? One in the summer in the Valley's greenery and then in the fall when the leaves are starting to change their colour. Throw in some mountain climbs, wood trails, picturesque back roads and some spectacular views.

If I have caught your attention, then the Valley Ride Committee would like to offer the following:

- The Valley Challenge is for the individual rider and same mount for all rides. Hereafter referred to as the "team".
- The team must compete both days in the CTR at the Northville Heritage Centre in June and then both days in the CTR at the Ride with Skye in September. OR
- The team must compete both days in the IDR and JP at the Northville Heritage Centre in June and then both days in the IDR at the Ride with Skye in September.
- The four rides in each category will be used to determine the top rider/mount. Point calculations will be determined by placings in the rides. (ie 1st = 7points, 2nd = 6points, 3rd = 5points, etc and a point for finishing)
- There will be a High Point Cooler awarded in the CTR and the IDR categories.
